#### **Resource Consent Applications**

The membership was advised of a mussel farm renewal application in Pipi Bay and an application to harvest two small blocks of trees near Opihi and Wangakoko Bays. No further action was taken by the Association on either of these.

## **Fishing Regulations**

The membership was advised of a proposal to change the regulations regarding smaller daily bag limits when catching paua and crayfish. At the time of this writing these new regulations have not gone into effect but all persons should check for any updates before collecting paua or crayfish this summer. The scallop fishery in Port Underwood is still closed for both commercial and recreational fishers.

#### Marlborough Long-Term Plan

The Association made a submission to the Marlborough Long Term Plan centred around roading and fair distribution of the Rating intake of funds.

Our comments on roading included the need to adequately maintain rural and unsealed roads along with a system which specified the standard to which the roads are to be maintained. With the new central government comes a roading classification based on usage which prescribes the different roading regimes. Central government has also put forward a notice of priority on road safety which may reduce the amount of money able to be spent on road maintenance. The Association will

continue to be involved with discussions as it is quite clear that safety on many rural roads is dependent on adequate maintenance to keep the roads in a safe drivable condition.

The Association supports a review of the manner in which rating intake is allocated. However, we have stated that it is important that the revised distribution of the rating intake is well thought out, researched and transparent.

# **Recycling bin location**

The Association applied to the Marlborough District Council to have a recycle bin located in our area. That has been approved and the membership was canvassed as to the best location for it. It appears that the consensus is alongside Port Underwood Road just uphill of the Tumbledown Bay Road turnoff. This is to be confirmed with a site visit with Council soon and the recycle bin should be in place before the holidays.

It is important that this bin is used properly. It is for recyclable items only and if it is full come back later or take your items into town. Do not leave items on the ground around the bin. This bin is for the improvement of Port Underwood, not as a site to create a rubbish pile.

## Activities at the Oyster Bay wharf

Arising from the recycle bin location request we received comments regarding activities and congestion at the Oyster Bay wharf. It is important that people remember that this is a seven day a week working area used by commercial industries.

Recreational users must be aware of safety hazards created by large trucks turning and backing, commercial trucks, barges and boats loading and unloading, people wandering around unaware of risks, children (and dogs) playing unsupervised while parents launch boats, fishing from the wharf while vessels are trying to tie up, people wandering around close to vessels fuelling up.

Recreational vehicles can cause congestion with cars and boat trailers parked along the road and wharf area sometimes left for days with no way of contacting the owner, or waiting for the launching ramp and blocking access or turning and loading/unloading of commercial vehicles.

There can be problems with recreational vessel speeds around moorings and the wharf - towing kids on biscuits, jet skis racing between moorings, or in general boats going too fast close to shore and wharves which creates wake issues.

The rubbish bins at the wharf area are for commercial users who pay Port Marlborough for them. Don't abuse them. Carry your rubbish into town.

Common sense, respect and courtesy for all will mean that these issues will no longer be problems.

# Defibrillator (AED)

If a person's heart has stopped there is only a short period to enable a recovery and emergency services need to be contacted immediately. CPR will keep blood moving and get air into the lungs. An AED can also help. An AED or defibrillator is a portable device that assesses a person's heart rhythm. It decides whether a defibrillation shock is needed and will apply it. The AED uses voice or visual prompts to guide a user; anyone can use an AED – you don't have to be medically qualified, but obviously training helps, as does any basic first aid training. Knowing where a defibrillator is located is a great start. In the Port Underwood area they are located at:

Waikawa Bay launching ramp – External cabinet opposite playground 24/7 access. 633 Port Underwood Rd, Picton – variable access, call 03 573 5599 Hakana Bay, - variable access, call 021 318 622. 2454 Port Underwood Rd, Ocean Bay – variable access, call 0221 306 508 Rarangi fire station – no public access, call 111

There are over 100 AEDs in Blenheim and 40 in the Picton area. To find an AED, you can find them at <u>https://www.heartsaver.co.nz/know-find-nearest-aed/</u> and it is believed you can download an app as well.
